What: This camp is for those students who attended WSCF camps this summer and/or students who have participated in 2010-2011 chess tournaments and have a 500 rating or higher. This camp will focus on those who are close to completing their pawn certificates and those wishing to complete their knight certificates. Camp will focus on chess tactics, game analysis, and game ending and opening strategies. Participants will play competitively for Wisconsin rating in quads of their ability level. Parents do not need to stay. Students will take home a rubric on material needed to complete their certificates or be awarded the pawn or knight certificate. Those completing the knight material quickly will move on to the bishop material.
